5. REVIEW, CONSIDERATION, AND POSSIBLE ACTION REGARDING APPLICATION(S) FOR MEDICAL LICENSE.

A. Samuel Zuniga
Applicant appeared via telephone.

Ms. Anthony summarized Samuel Zuniga submitted an application for licensure by examination. Source documents indicated an arrest took place on 12/24/2016 for public intoxication. Mr. Zuniga failed to notify the Board at the time of the arrest, and failed to indicate the arrest on his application.

Dr. Sadilek asked Mr. Zuniga why he failed to check the appropriate box on the application. Mr. Zuniga stated it was an oversight on his part. Dr. Popiel stated he agreed with Dr. Sadilek that it is a concern.

Ms. Anthony clarified there are two incidents of failure to disclose. Mr. Zuniga was under the jurisdiction of the Board at the time of the arrest because he held a certificate to engage in clinical training, and failed to disclose the arrest at that time. The second failure was not indicating the arrest on his application for licensure.

Dr. Campbell stated that falsification on an application is serious, and asked Mr. Zuniga what type of assurance he can give the Board that this will not happen again. Mr. Zuniga stated the only assurance he could give was a verbal promise he will not omit information from the Board again, and is taking more care with his alcohol consumption. Dr. Sadilek asked Mr. Zuniga if he has a problem with alcohol. He stated he does not.

Dr. Popiel made a motion to approve the application for medical license. Seconded by Ms. Tibbitts.

Dr. Spat stated there are a lot of concerns regarding this applicant, and asked if there is anything else the Board can do.

Ms. Asta stated the Board does have options, which she would be happy to review with the Board in Executive Session.

Dr. Spat made a motion to go into executive session for legal advice. Seconded by Dr. Sadilek.

B. Sarah Coultas
 Applicant appeared via telephone.

Ms. Anthony summarized Sarah Coultas submitted an application for licensure by endorsement, limited scope. Verifications indicate she holds a current license to practice naturopathic medicine in Hawaii, she held a license to practice naturopathic medicine in Washington which expired due to non-renewal, and held an Arizona Massage Therapy license, which is also expired due to nonrenewal. Verification of all are in good standing with no disciplinary actions. Ms. Coultas indicated a prior arrest on her application and submitted the appropriate documentation with her application. 6. REVIEW, CONSIDERATION, AND POSSIBLE ACTION REGARDING FEE WAIVER APPROVAL, PURSUANT TO EXECUTIVE ORDER 2020-17 (2.), (3.)(Z).

Ms. Anthony summarized the request for fee waiver is based on Executive Order 2020-17, which allows any fees required to be collected by the board to be waived at the board's discretion. This order is in response to the COVID-19 pandemic, and in place until further notice. Ms. Anthony explained the waiver should have no negative monetary impact to the Board, based on the excess revenue being generated. At the time the order is repealed, the Board can review the revenue to make a determination if reduction of fees should be continued.

7. REVIEW, CONSIDERATION, AND POSSIBLE ACTION REGARDING IMPLEMENTATION OF ELECTRONIC OR REMOTE FORMAT FOR JURISPRUDENCE EXAMINATIONS, PURSUANT TO EXECUTIVE ORDER 2020-17 (1.)(D).

Ms. Anthony summarized the request for consideration and approval is based on Executive Order 2020-17, which orders boards to make every attempt to implement electronic or remote format examinations for licensure. Southwest College of Naturopathic Medicine recently implemented the ability to proctor examinations through a secured online process. Ms. Anthony explained the majority of the jurisprudence examinations are given at a time when the students enter clinic at the college, and requested the board approve the online examination method proposed.
