#### (2) Dr. Wendy Wells, Case No. 16-049 - Investigative Interview

Dr. Marchese recused herself. Dr. Wells was presents and explained that although patient AK alleges she failed to order a lipid panel, the Sonora Quest Laboratory requisition does indicate one was ordered. However, patient AK chose to have his blood drawn at Central Clinical Labs. The error occurred when a technician at CCL, failed to transfer the lipid panel request to their lab's requisition. AK alleges the wrong lab results were faxed to his cardiologist however, records indicate results were not faxed because AK refused to sign a release of records form. Results were given to patient AK. Chart notes indicate staff answered all phone contacts, and it was ultimately AK who severed the association with the physician by telling the staff not to have the physician call him back. Dr. Sadilek made a motion to dismiss the case. Seconded by Ms. Tibbits. Motion Carried 4 Ayes, 1 recused, 2 Absent.

**(3) Dr. Erin Winter, Case No. 15-027 - Formal Interview.**

Dr. Winter was present. The initial complaint was received by the Department of Health Services, regarding an alleged discrepancy in the number of medical marijuana certifications processed by Respondent, Vs. the number of times she accessed the prescription monitoring program database. Upon investigation into the matter, it was discovered Respondent had accessed the database beyond the number of patients she certified for medical marijuana during the time frame in question. The error took place between the Department of Health Services and the Pharmacy Board during the initial audit. Upon Board review of 10 patient records, it was discovered records for three of the patients were not adequate. Dr. Sadilek made a motion to issue an order for six (6) hours of non-disciplinary CME in muscular skeletal rehabilitation. Seconded by Mr. Logan. Motion Carried 5 Ayes, 2 Absent.

Dr. Sadilek agreed and stated he felt a more comprehensive evaluation was required, because the incident was recent, and the alcohol level was extreme at the time of the arrest. Dr. Marchese made a motion to order Applicant to participate in an independent alcohol evaluation by a licensed psychologist, psychiatrist, or behavior health professional pre-approved by board staff, and that the issuance of the certificate is dependent on the outcome of the evaluation.
