(3) Dr. Herbert Schuck - Case No. 15-010, Investigative Interview.

Dr. Schuck was present. According to the Arizona Department of Health Services, from January 1, 2014 through June 30, 2014, Respondent approved certifications for Medical Marijuana. By initialing each certification, Respondent attested he had queried and reviewed each patient *prior* to certifying them for Medical Marijuana. According to source documents, Respondent only accessed the database and queried .7% of the patients he certified during that time period. After review of Respondent's records by the Board, it appears he may not have kept adequate medical records as defined by A.R.S. 32-1501(3). Further it is alleged by the Board, Respondent may not have provided appropriate standard of care, by failing to conduct a physical examination appropriate to the qualifying patient's presenting symptoms and debilitating medical condition, and by relying on medical records from a Chiropractor. Ms. Bennett made a motion to move the case forward to a Formal Interview. Seconded by Dr. Sadilek. Motion Carried 6 Ayes, 1 Absent.
