- C Current Number of Board Cases Under Investigation, Pending Before OAH, or On Hold Pending Outcome of Criminal Case.
- D. Summary of Case Dismissed by the Executive Director

12. REVIEW, CONSIDERATION, AND POSSIBLE ACTION REGARDING APPOINTMENT OF, BOARD CHAIR, BOARD VICE-CHAIR, AND BOARD SECRETARY.

The Board may vote to go into Executive Session pursuant to A.R.S. § 32- 431.03(A)(2)(to discuss confidential information) or A.R.S. § 38-431.03(A)(3)(to receive legal advice).

13. REVIEW, CONSIDERATION, AND POSSIBLE ACTION REGARDING CONTINUING MEDICAL EDUCATION CREDIT FOR SERVING ON THE BOARD.

The Board may vote to go into Executive Session pursuant to A.R.S. § 32- 431.03(A)(2)(to discuss confidential information) or A.R.S. § 38-431.03(A)(3)(to receive legal advice).

15. CALL TO THE PUBLIC

Those wishing to address the Board do not need to request permission in advance; however, the Board may limit those persons speaking during this time to a reasonable number on any public comment matter.
