PUBLIC RECORDS REQUEST FORM

(Title 32, Arizona Revised Statutes)

What information is available on the Board's website?

Almost all of the Board's public information on a physician is available on its website. Under the Physician Search tool, you can find the physician's name, license number, license status, license renewal date, address, and phone number. Pursuant to A.R.S. 323226 (A), a licensee may opt out of public disclosure if the residential address is the only address on file. Meeting agenda's and meeting recordings are also available on the Boards website. Review A.R.S. 32-3214 Below

What is considered to be public information?

License file information, board actions (i.e. Letter of Reprimand, Decree of Censure, Probation, etc.), board meeting agendas and minutes or board recordings.

What information can I obtain that isn't on the Board's website?

Copies of license applications and pertinent licensing information, dismissal letters, and advisory letters are available on written request.

Review A.R.S. 32-3214 Below

A.R.S. 32-3214. Board actions; public access to records; website

A. If a health profession regulatory board dismisses a complaint, the record of that complaint is available to that regulatory board and the public pursuant to section 39-121 but may not appear on the board's website. For the purposes of this subsection, "dismisses a complaint" means that a board does not issue a disciplinary or nondisciplinary order or action against a licensee or certificate holder.

B. All disciplinary actions against a licensee or certificate holder shall be available on the health profession regulatory board's website for not more than five years. If a health profession regulatory board issues a final nondisciplinary order or action, the record of the final nondisciplinary order or action shall be made available on the board's website for not more than five years. Letters of concern and advisory letters may not be made available on the website but a copy of such letters are available to the public pursuant to section 39-121 and shall be provided to any person on request.

Reproduction costs may apply and shall be paid by cashier check, or money order made payable to the AZ. ND Board, or by Cash. A charge of \$.25 per page will apply. Copies may be emailed at no charge.
