**Dr. Sadilek made a motion to accept the consent agenda, items 3(A),(C),(D),(E),(F),(G),(H),(I),(J),(K). Seconded by Ms. Golliglee. Motion carried, 5 Ayes, 2 Absent.**

**4. Regulatory Matters**

**A. Discussion, Consideration, Possible Action by the Board of Investigations and Complaints. The Board may go into executive session on any of the following items under A.R.S. §38-431.03(A)(2), for discussion of any information made confidential by law.**

**(1) Dr. Sam Walters, Request for Board Evaluation of Early Probation Termination**

Attorney David Smith was present, made statements and answered questions. After discussion and consideration by the Board, Dr. Sadilek made a motion to grant early termination of Probation. Seconded by Ms. Golliglee. Motion carried, 5 Ayes, 2 Absent.

Item 4 A(2) and (3) were taken into consideration by the Board in reverse order.

**(2) Dr. Bianca Munoz, Case No. 11-021 – Investigative Interview**

Dr. Munoz was present along with Attorney Greg Fairbourn. After discussion and consideration by the Board, Ms. Golliglee made a motion to dismiss the case. Seconded by Dr. Sadilek. Motion carried 5 Ayes, 2 Absent.

**(3) Dr. Bianca Munoz, Case No. 10-038 – Formal Interview**

Dr. Munoz was present along with Attorney Mr. Greg Fairbourn, both made statements and answered questions. After discussion and consideration by the Board, Dr. Walker made a motion to give staff the ability to negotiate a consent agreement to include issuance of a Letter of Reprimand, one year probation and 8 hours of additional Continuing Medical Education specific to classification of controlled substances and other prescription medications. Seconded by Dr. Sadilek. Roll Call: Dr. Eldridge; Aye, Ms. Broadman; Aye, Ms. Golliglee; Aye, Dr. Sadilek; Aye, Dr. Walker; Aye. Motion carried 5 Ayes, 2 Absent.

**(4) Dr. Ben Zorensky, Case No. 12-005 – Investigative Interview, Review of Proposed Consent Agreement.**

Dr. Zorensky was present, made statements and answered questions. After discussion and consideration by the Board, Dr. Walker made a motion to accept the consent agreement signed by Dr. Zorensky. Seconded by Ms. Golliglee. Motion carried 5 Ayes, 2 Absent.

**(5) Dr. Andrea O'Connor, Case No. 11-016 – Investigative Interview**

After discussion and consideration by the Board, Dr. Walker made a motion to move the matter to Formal Interview while giving staff the ability to negotiate a consent agreement to include a 30 day suspension of Dr. O'Connor's license, 24 hours of additional continuing medical education in record keeping, pain management, and law and ethics and a civil penalty of \$1000. Seconded by Ms. Golliglee. Motion carried 5 Ayes, 2 Absent.

**(6) Dr. Andrea O'Connor, Case No. 12-004 – Investigative Interview**

After discussion and consideration by the Board, Dr. Sadilek made a motion to dismiss the case. Seconded by Ms. Broadman. Motion carried 5 Ayes, 2 Absent.

Items 4 A(7),(8) and Item 4 B were taken into consideration prior to Items (4), (5) and (6). Item 4 (8) and 4 B were taken into consideration by the Board in combination and prior to 4 A (7).

**(7) Dr. Alexander de Soler, Case No. 11-015 – Investigative Interview**

Dr. de Soler was present along with Attorney Mr. Kelly McDonald. Both made statements and answered questions. After discussion and consideration by the Board, Dr. Sadilek moved to accept the consent agreement as drafted. Seconded by Dr. Walker. Roll Call: Dr. Sadilek; Aye, Ms. Golliglee; Aye, Ms. Broadman; Aye, Dr. Eldridge; Aye, Dr. Walker; Aye. Motion carried 5 Ayes, 2 Absent.

**(8) Dr. Alexander de Soler, Case No. 11-023- Investigative Interview.**

Dr. de Soler was present along with Attorney Mr. Kelly McDonald. Both made statements and answered questions. After discussion and consideration by the Board, Dr. Sadilek made a motion to accept the amendment to order 10-029. Seconded by Ms. Golliglee. Motion carried 5Ayes, 2 Absent.

After discussion and consideration by the Board, Ms. Golliglee moved to approve the rules. Seconded by Dr. Sadilek. Motion carried 5 Ayes, 2 Absent.
