3. Discussion, Consideration and Possible Action by the Committee Regarding Review of Questions Rewriting the State of Arizona Naturopathic Physicians Medical Board Jurisprudence Examination.

The committee discussed expanding the subject matter covered in the exam(s) to include Arizona Revised Statutes (A.R.S.) Title 32; Chapter 14, Administrative Rules, Title 32; Chapter 14, Sections of A.R.S. Law Related to Medicine, Sections of Arizona Administrative Rules other than Title 32 Chapter 14 that apply to Title 32 Chapter 14, Sections of the United States Code that apply to Title 32; Chapter 14, State of Arizona Department of Health Services, State of Arizona Board of Pharmacy (A.R.S. 32-1901 - 1996), and possible other subject matter as determined by the committee. The committee also discussed the concept of splitting the examination into three parts; making part one a requirement for 1st year students, part two a requirement for students entering clinical training and the third part a requirements to be taken prior to graduation.
