Ms. Barron moved to accept the consent agenda, Seconded by Mr. Micuda. Motion carried 5 Ayes, 2 Absent

4. Regulatory Matters

- A. Discussion, Consideration, Possible Action by the Board of Investigations and Complaints. The Board may go into executive session regarding this matter.

After discussion and consideration by the Board, Mr. Micuda moved to forward the case to Formal Hearing giving Dr. Runbeck the ability to accept a signed consent agreement for surrender, in the form of what was presented in the Board packet, in the event Board staff receives one prior to the Formal Hearing. Seconded by Dr. Waldman. Motion carried 6 Ayes, 1 Absent.

(2) Dr. Henry Ealy, III, Review and possible vote on opening a case for non compliance of Board Order.

Dr. Ealy was present. After discussion and consideration by the Board, Dr. Walker moved to open a case on the basis of non-compliance of Board Order. Seconded by Mr. Micuda.
