The consideration of the application for renewal of certificate to dispense for Alexis Osborn McNeil was taken into consideration. Dr. Walker recused herself. Ms. Barron moved to accept the application for renewal of the certificate to dispense for Dr. McNeil. Seconded by Mr. Micuda. Motion carried 6 Ayes, 1 Recused.

4. Regulatory Matters

- A. Discussion, Consideration, Possible Action by the Board of Investigations and Complaints. The Board may go into executive session regarding this matter.
 - (1) Dr. Chrystie Eggerling; Case no. 10-005 Investigative Interview.

Dr. Eggerling was present, made statements and answered questions. After discussion and consideration by the Board, Dr. Sadilek moved to forward the matter to Formal Interview allowing staff the ability to negotiate a consent agreement. Respondent stated she believed some of the prescriptions reflected in the PMP report may be fraudulent and requested the opportunity to review them. The Board requested staff to obtain copies of prescriptions from the pharmacies. Seconded by Mr. Micuda. Motion carried 7 Ayes.

(2) Dr. Sam Walters; Discussion and Possible Action by the Board regarding Case 09-052 and Case 10-001. Counsel presentation of proposed consent agreement.

Dr. Walters was present with Counsel Mr. David Smith and Mr. Steven Myers. Counsel requested, and was given an opportunity to present a proposed consent agreement to the Board.

A break was taken at 1:30 PM in order to the Board time to review the packet of material provided by Counsel. The Board returned to regular session at 1:38 PM.

The Board gave staff the directive to bring back a finalized version of the consent agreement to the next meeting for Board consideration and possible vote.

(3) Dr. Grant McKernan, Case no. 10-004 – Investigative Interview.

Dr. McKernan was present, made statements and answered questions. After discussion and consideration, Mr. Micuda moved to forward the matter to Formal Interview, giving staff the ability to negotiate a consent agreement. Seconded by Mr. Zang. Motion carried 7 Ayes.

The Board took a break at 2:10 PM and returned to regular session at 2:15 PM.

(4) Dr. Kyle Neeley, Case no. 10-012 – Investigative Interview.

Dr. Neeley was present with Counsel Mr. Charlie Bird. Dr. Neeley made statements and answered questions. After discussion and consideration, Dr. Sadileck moved to dismiss the case, Seconded by Ms. Barron. Motion carried 7 Ayes.

Dr. Kruzel was present, made statements and answered questions. After discussion and consideration by the Board Mr. Micuda moved to dismiss the case. Seconded by Dr. Waldman. Motion carried 7 Ayes.

(7) Kelly Hannigan-Lewis, Petition for Licensure Reinstatement

Kelly Hanningan-Lewis was not present. Dr. Rubin made a motion to go into Executive Session for Legal advice. Seconded by Dr. Walker. Executive Session was entered into at 2:45 PM

Regular Session resumed at 2:55 PM

After discussion and consideration by the Board, Mr. Micuda made a motion to deny the reinstatement of the license based on the fact the applicant charged a fee for services not rendered, considered unprofessional conduct under A.R.S. § 32-1501 (31), and taking into account the psychological evaluation report submitted to the Board by Dr. Di Bacco, without treatment, the applicant may be unable to safely engage in the practice of naturopathic medicine at this time. Seconded by Dr. Sadilek. Roll Call: Dr. Sadilek: Aye, Ms. Barron; Aye, Dr. Waldman: Aye, Mr. Micuda: Aye, Mr. Zang; Aye, Dr. Rubin; Aye, Dr. Walker; Aye. Motion carries 7 Ayes.
