## (1) Dr. Jennifer Burns, Case No. 09-051, Investigative Interview.

Dr Burn's was present with her attorney Mr. Steve Myers. Dr. Burns made statements and answered questions. After discussion and consideration by the Board, Dr. Rubin made a motion to dismiss the complaint and issue a Letter of Concern to include staff recommendations 1, 2 and 3 also to include compliance with contemporary record keeping and an order for 1 hour of non-disciplinary CME in the process of prescription writing.
