M. Discussion, Consideration, Possible Action by the Board Regarding Possible DEA Reclassification of Certain Pharmaceuticals.

Mark Barnes; Lobbyist representing the AzNMA, and Ms. Cathy Stuart; Executive Director of the AzNMA, were present and addressed the board. The possible reclassification of certain pharmaceuticals by the DEA were discussed. Also discussed was the legislation efforts by Mr. Barnes, on behalf of the AzNMA, to protect the current prescribing scope of naturopathic physicians licensed in Arizona. Proposed legislation would also support the addition of naturopathic physicians to the current telemedicine statute.

After discussion and consideration by the Board, Dr. Marchese made a motion to support the legislation to maintain the status quo of prescribing rights for naturopathic physicians in Arizona. Seconded by Dr. Sadilek. Motion carried 4 Ayes, 3 Vacant.

After discussion and consideration by the Board, Ms. Reeve made a motion to support the legislation to add telemedicine to naturopathic medical providers. Seconded by Dr. Sadilek. Motion carried 4 Ayes, 3 Vacant.

Ms. Reeve made a motion to continue with Dr. Sadilek as Chair, herself as Vice-Chair and Dr. Marchese as Secretary/Treasurer. Seconded by Dr. Sadilek. Motion carried 4 Ayes, 3 Vacant.
