Dr. Richardson explained she did not agree with the topic of medical triage for CME. After discussion with Dr. Richardson, the Executive Director felt a more appropriate subject matter could be the risks and benefits of treating patients with Anticoagulant therapy. The language was changed, and a new order presented to Dr. Richardson for her signature.
